1 Introduction

1.1 Product description

This product allows to control SAVE ventilation unit with a mobile application or any internet browser, both locally (WLAN) and remotely via internet.

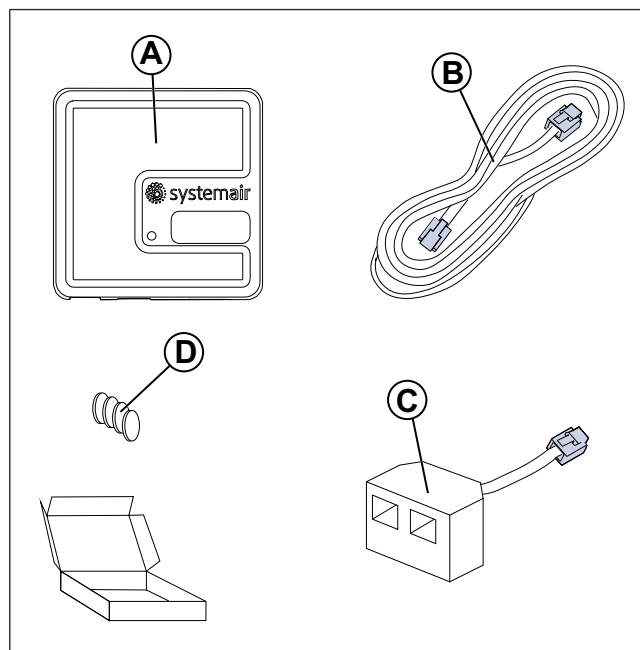
Note:

- SAVE CONNECT must be easily accessible and installed in a warm dry area with a good Wi-Fi signal.
- SAVE CONNECT only supports 2.4 GHz wireless frequency.
- SAVE CONNECT module uses MQTT port 1883 for outgoing connections.

The SAVE CONNECT module also provides additional features:

- software updates
- remote technical service
- configuration file import and export function

5 Troubleshooting

5.1 To reset to default settings

1. Disconnect the cable (B) from the SAVE CONNECT module.
2. Press and hold the button on the SAVE CONNECT module and while the button is pressed, reconnect the cable.

The LED will start to flash in red colour.

3. Continue to hold down the button until the LED stops to flash (~10 seconds) and then release the button.
